2. HAZARDS IDENTIFICATION SUMMARY

4. FIRST AID MEASURES

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If in swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

5. FIRE FIGHTING MEASURES

SPECIAL FIRE FIGHTING PROCEDURES: Wear self-contained breathing apparatus and full protective clothing. Fight fire from upwind and keep all non-essential personnel out of area of intense smoke.
UNUSUAL FIRE AND EXPLOSION HAZARDS: If water is used to fight fire, contain runoff, using dikes to prevent contamination of water supplies. Do not allow water runoff to enter nearby streams, ponds or lakes. Keep containers cool with water spray.

6. ACCIDENTAL RELEASE MEASURES

STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED:

In case of leak or spill, contain by absorbing with clay or other absorbent material; scoop or sweep up material and place in a container for possible land application according to label use or for proper disposal. Wash the spill area with water containing a strong detergent. Check local, state and federal regulations for proper disposal.

CAUTION: Keep spills and cleaning runoff from flowing onto adjacent land, or into municipal sewers and open bodies of water.

7. HANDLING AND STORAGE

HANDLING: Wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

STORAGE: Store in original container only. Do not store in direct sunlight. Do not store at temperatures above 120°F / 48.9°C. If stored above 120°F, Balan DF could lose some of its dispersing properties, resulting in difficult application, poor weed control or crop injury. Do not contaminate water, food or feed by storage or disposal.

Personal Protective Equipment: Applicators and other handlers must wear: long sleeved shirt and long pants, socks plus shoes, and chemical-resistant gloves made of any waterproof material. All mixers, loaders, and applicators must wear goggles or face shield. Follow manufacturer's instructions for cleaning and maintaining PPE. If no instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry.

8. EXPOSURE CONTROLS / PERSONAL PROTECTION

ENGINEERING CONTROLS: When handlers used closed systems, enclosed cabs, or aircraft in a manner that meets with the requirements listed in the Worker Protection Standard (WPS) for agricultural pesticides [40 CFR 170.240 (d) (4-6)], the handler PPE requirements may be reduced or modified as specified in the WPS.

12. ECOLOGICAL INFORMATION

Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Pressure rinse as follows: Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. Do not contaminate water, food or feed by storage or disposal.
